Article III:

Media and the Submission Material Support

The registration form must be filled with data to be published in Catalog of the event, case the film is selected. The director shall send 01 (one) copy of the film: DVD or MiniDV tape with the registration form of work, material support and dissemination (01 photos including picture of the director, releases Minimum font 12, 01 page A4, synopsis of the work), for the production of CINECUFA.

The films must be identified with the full name directly in the media, becoming part of the acquis of CUFA and can be used in CINECUFA Co Related festivals, which were accomplished by the institution itself. There is no limit for submissions. In case of registration of more than one job, they may be on the same DVD /MiniDV, if properly identified.

Article IV:

The Accuracy of Information

It is important that the filmmaker make the pre-registration online, print and sign the same should occur with the permission of screening of the film following the template available on the website, as well as copies of the identity of the author / producer of the work that is according to the rules of the Festival. ALL must be sent together with the work and supportive materials mentioned in item II (of entries) for the Production of CINECUFA 2011.

Works that may participate in CINECUFA includes: works in all shapes, lengths and genres, highlighting the importance of such products meets the ultimate goal of the festival which is films from the peripheries made by residents / representatives from the peripheries. Upon signing your work the producer will be legally responsible for submitting correct information, as well as their copyright, title and release for public viewing. Once selected, the film cannot be removed from the festival throughout its duration.
